THE INDEPENDENT CITIZENS REDISTRICTING COMMISSION

California's Most Important Election Reform in the Past 50 Years

For decades, Sacramento politicians drew their own district boundaries behind closed doors with no public oversight — guaranteeing their reelection, denying voters a real choice, and shutting out many women and people of color from elected office.

In 2010, California voters overwhelmingly approved the Voters FIRST Act for Congress entrusting the independent, 14-member Citizens Redistricting Commission to draw California's Congressional districts.



Created constitutional safeguards that require district boundaries to keep cities, counties, and local communities together.

Strengthened voter protections that ban maps designed to favor incumbents or political parties.

Expanded a transparent and public process for redistricting that requires all meetings are open to the public, maps are published in draft form for feedback, and commissioners must respond to public input.

Enforced strict conflict-of-interest rules that bar redistricting commissioners for 10 years from running for office in districts that they have drawn.

A SPECIAL ELECTION TO BACK THE CLOCK ON FAIR ELECTIONS

Politicians in Sacramento are rushing to abolish the Citizens Redistricting Commission's authority over congressional districts — with plans for a statewide special election in just a few months that will cost \$200 million.

Their plan to strip away California's constitutional voter protections would:

- **End Independent Maps**Gives politicians the power to draw districts that protect themselves not voters.
- Silence Voter Voices
 Eliminates public input and transparency from the redistricting process.
- **Open the Door to Gerrymandering**Allows politicians to manipulate maps to serve their interests not our communities.
- Set a Dangerous Precedent
 Weakens constitutional protections and opens the door to future abuses.
